

TOWN OF FORT FRANCES

BY-LAW NO. 37/15

(Being a by-law to provide for traffic controls and parking restrictions along a temporary detour route during reconstruction of King’s Highway, between York Avenue and Wright Avenue, the Municipal Act, R.S.O. 2001, the Highway Traffic Act, R.S.O. 1990).

WHEREAS on May 25, 2015 By-Law 30/15 was enacted by Council to approve the reconstruction, watermain and sewer replacement of King’s Highway from York Avenue to Wright Avenue;

AND WHEREAS on June 22, 2015, Council approved temporary traffic and parking control measures along detour routes while the King’s Highway reconstruction, watermain and sewer replacement occurs between York and Wright Avenues;

NOW THEREFORE Council for the Corporation of the Town of Fort Frances HEREBY ENACTS as follows:

1. That, in addition to the provisions of Town of Fort Frances By-Law No. 21/14, the Traffic Control By-Law, the interim traffic controls and parking restrictions be in effect as follows:

1) SPECIAL STOP SIGNS:

<u>NO.</u>	<u>INTERSECTION</u>	<u>FACING TRAFFIC</u>
1.	Third Street W. and Webster Ave.	Eastbound on Third Street W.
2.	Third Street W. and Webster Ave.	Westbound on Third Street W.
3.	Wright Avenue and Third Street W.	Southbound on Wright Ave.
4.	Wright Avenue and Third Street W.	Northbound on Wright Ave.
5.	Wright Avenue and Second Street W.	Southbound on Wright Ave.
6.	Wright Avenue and Second Street W.	Northbound on Wright Ave.
7.	King’s Hwy and Wright Ave.	Westbound on King’s Hwy.
8.	Wright Avenue and Fourth Street W.	Northbound on Wright Ave.

The restrictions imposed by the special stop signs in this section are the same as imposed in Section 5.17.2 of Town of Fort Frances By-Law No. 21/14 and as if included in Schedule “T” (Special Stop Signs) under said By-Law No. 21/14.

2) RESTRICTED PARKING AREAS:

<u>NO.</u>	<u>STREET</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>	<u>PERIOD</u>
1.	Wright Ave.	Both	King’s Hwy	Fourth St. W.	Friday & Saturday
2.	Fourth St. W.	Both	Wright Ave	Central Ave.	Commencing 12:01am Friday Ending 11:59pm Saturday

The restrictions imposed in this section are the same as imposed in Section 4.4.1 of Town of Fort Frances By-Law No. 21/14 and as if included in Schedule “D” (Restricted Parking Areas) under said By-Law No. 21/14.

If it is determined to be in the public interest to impose, in addition to the specific controls and restrictions included in Section 1. above, certain additional restrictions in the form of traffic controls and/or parking restrictions on a temporary basis along said

alternative traffic routes, then the installation of all such signs or traffic control devices is hereby authorized and said signs or traffic control devices so installed under authority of this section shall be enforceable in similar manner as though they were installed under authority of Town of Fort Frances By-Law No. 21/14, the Traffic Control By-Law.

2. The provisions of this by-law shall be in force and effect only during the reconstruction, watermain and sewer replacement of King's Highway between York Avenue and Wright Avenue (Contract 15-OF-10).

This by-law shall come into force and take effect on the final passing thereof.

READ THREE TIMES and finally passed in open Council this 22nd day of June 2015.
